Begun and held in Cotabato City, on Tuesday, the twenty-seventh day of April, nineteen hundred and ninety nine.

[MUSLIM MINDANAO AUTONOMY ACT 123]

AN ACT APPROPRIATING FUNDS FOR THE OPERATION OF THE AUTONOMOUS GOVERNMENT IN MUSLIM MINDANAO FROM APRIL ONE TWO THOUSAND ONE TO MARCH THIRTY ONE TWO THOUSAND TWO, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. Appropriation of Funds. - The amount of One Hundred Thirty Million Pesos (P130,000,000.00) generated out of local revenues is hereby appropriated for the operation of the Autonomous Regional Government from April 1, 2001 to March 31, 2002.
